Instrumental biocommunication in equine practice

Hope for chronically ill patients when other treatment options have been exhausted

As in human medicine, holistic therapy approaches are also increasingly being pursued in veterinary medicine. This is based on the awareness that comprehensive and long-term recovery is only possible if the causes of an illness or health disorder are identified and removed. But despite the sophisticated diagnosis techniques available, it is often still difficult to answer the question of why – to recognise where causes lie. With the aid of instrumental biocommunication, there evidently exists a further possibility, above and beyond the known diagnosis techniques, of gathering important patient information which covers the environment, living conditions and stresses of the patient, and thus facilitates for the therapist the important research into the cause.

The fact that something is not in order with one's horse in the truest sense of the word is generally only noticed by the horse-owner when disorders make themselves apparent by means of external symptoms. The horse behaves differently than usual, is less capable or even has severe physical complaints. Therapists and vets are therefore first confronted with these apparent changes. In terms of holistic healing methods, the cause of a disorder can however originate from a completely different part of the body, sometimes even without any direct correlation in time. The desired treatment success therefore often fails to materialise.

Ute Clausing considers the possibility of instrumental biocommunication as an important complement to the other methods used in her veterinary practice. With an individual analysis, by means of a physical surrogate, for example some blood or a few hairs of the patient, she attempts to get to the bottom of the problems or the weak points in the organism.

She runs an Arab stud in Rottenburg in Lower Bavaria, and also manages her practice, in which she treats mainly horses and dogs, but also cats, small animals and birds. "I personally am particularly interested in the analysis and therapy of headshaking, COPD, chronic movement problems, behavioural disorders and summer eczema", reports the therapist, thereby simultaneously summarising a range of illnesses which are often very difficult or even impossible to come to grips with in equine veterinary practice. Pulmonary disorders for example are still amongst the most frequent causes of premature death in horses.

One such candidate for example was the pony Mona, which was first brought to the practice several years ago:

"Over the years, my pony developed chronic obstructive bronchitis due to an allergy to hay dust, together with a heart valve defect", remembers the owner. Despite intensive orthodox

medical treatment, the condition of the animal continued to deteriorate to the point where it looked as though the 23-year old mare would have to be put down.

In the practice, a comprehensive analysis was now carried out, and on its basis a therapy schedule compiled, with the aid of instrumental biocommunication. The analysis consisted of a combination of phytotherapeutic and homeopathic measures, and putting the animal through the QUANTEC[®] machine. The transmission of the healing information to the patient, like the analysis of the surrogates, takes place via the diode with the white noise, the key component of the machine.

Following this treatment, the health condition of the mare fluctuated violently. When her condition deteriorated, the current treatment method was reviewed, and the potency changed if necessary, or the method itself even changed.

"After my pony was fully 'adjusted', a visible improvement set in within 24 hours of every necessary therapeutic change", observed the owner. In this way, it proved possible to stabilise Mona to the point where her quality of life was improved enormously.

Today, at the age of 27, the mare is enjoying her retirement with dry hay in the paddock, and now needs only one single homoeopathic complex agent.

Another typical fate of chronically ill horses is described by the owner of a quarter-horse mare:

“Ronja had various complaints. Inflammation of the inner hoof, allergic coughing, alternating lameness and confirmed borreliosis. This made it impossible for her to be ridden at times, and after this long odyssey, all the orthodox medical treatment possibilities were considered to be exhausted. I came to the conclusion that my horse would have to be considered and treated as a whole and began the search for a suitable therapist, as a last-ditch attempt, so to speak.”

Thanks to the intensive care in the veterinary practice and with the aid of instrumental biocommunication, the state of health of the mare has stabilised after 2 ½ years to the point where the owner is again having fun with her horse, and can again ride her during her leisure time.
